- 3) Communicate with me proactively and listen to what I have to say.
- 4) Make it easy to work here by taking away bureaucracy.
- 5) Enable me with visible, supportive and consistent leadership.
- 6) Recognise that workload's a problem. Appreciate me, and tell me that you do.

Hand Hygiene

Discussion held on the drop in hand hygiene compliance.

Orthopaedic Initiative

Noted NMH has a three year programme to complete additional joint surgeries. This year the number is highest in terms of additional surgeries (mostly hips). In the last six weeks, the team reached this target. Next year the number of additional joint surgeries will drop, however we will continue delivering above the intervention rate that MOH would expect for our population. This is a good news story.

Cancellations by Reason and Speciality

Concern raised regarding theatre cancellations. Options to improve the number of cancellations is being investigated.

Oral Health

Concern raised regarding Did Not Attend (DNAs) for vulnerable children. Noted in the Victory area, in Nelson, the Public Health team, TPO and other agencies are focussing on how we improve this issue, and other health improvements that are needed for this vulnerable group.
