# Response to a request for official information

Thank you for your request for official information received 4 December 2019 by Nelson Marlborough Health (NMH)<sup>1</sup>, followed by the necessary extension of time 23 January 2020 and notice of decision 21 February 2020, where you seek information on the historic track of coal burning.

1. The volume of coal burnt at the hospital over each of the last ten years at both Wairau and Nelson Hospitals.

#### NMH response

The volume of coal utilised since 2012 is shown in Table 1 below. Please note that the coal is measured on the quantity of tonnes delivered. NMH does not have readily retrievable records on coal utilisation prior to 2012.

# 2. The date of commissioning of the landfill gas boiler at Nelson Hospital and how much it has offset the burning of coal.

## NMH response

The landfill gas boiler was commissioned during the 2005/06 financial year. As noted in the response to question 1 we do not have records of coal utilization dating prior to 2012 so it is not possible to determine the offset that it has provided.

## 3. Any information on alternatives that have been explored and the scale of costs.

# NMH response

At the point of writing no alternatives have been explored for Nelson or Wairau Hospitals, other than the proposed trial of wood pellets at Nelson Hospital of which was recently reported to the Board.

The estimated cost of the wood pellets is circa \$100k higher (on an annualised basis) than we would expect for the equivalent energy generated by utilising coal however this cannot be confirmed until the trial has been completed. We will proceed with the trial once we have completed the analysis on what changes are required to the boiler infrastructure to enable the wood pellets to be used.

Further analysis on energy alternatives will be completed in the Detailed Business case phase of the planning for the Nelson Hospital redevelopment.
