Response to a request for official information

Dear

Thank you for your request for official information received 10 January 2020 by Nelson Marlborough Health (NMH)¹, followed by the necessary extension of time 13 February 2020, where you seek the following information:

Amongst other issues, we are trying to get an overview on the annual government budget for "population nutrition promotion", which is defined as "the investments in population promotion of healthy eating and healthy food environments for the prevention of obesity and diet-related NCDs, excluding all one-on-one promotion (primary care, antenatal services, maternal and child nursing services etc.), food safety, micronutrient deficiencies (e.g. folate fortification) and undernutrition". We are also contacting the Ministry of Health and the Health Promotion Agency for information on their population nutrition promotion budgets.

We would like to get an estimate of your DHB budget for population nutrition promotion (as per definition above) over the last 3 years (2017/18, 2018/19, 2019/20). It would be helpful if you could clarify how much of this budget is transferred to PHUs and/or PHOs. I realise that sometimes it is difficult to separate nutrition promotion from other health promotion activities such as physical activity.

The expenditure by NMH through the Public Health Service contract towards 'Nutrition and Physical Activity' is outlined in Table 1. This does not include expenditure which NMH has provided to the Primary Health Organisations (PHOs) toward nutrition and physical activity programmes as these are mostly focussed on personal health, although there are elements of population health activity. As you suggest, we are unable to separate the portion toward 'Physical Activity' from 'Nutrition' promotion.
