

Response to a request for official information



Thank you for your request for official information received 27 February 2020 by Nelson Marlborough Health (NMH)¹, followed by the necessary extension of time 26 March 2020 and notice of decision 28 April 2020, where you seek information on reported assaults /harassment.



The categories requested do not exactly match our reporting categories, and the data provided reflects the best match to that which we are able to provide

1. The number of sexual harassment reports made by person(s) employed (staff) by the DHB in the calendar years of 2019, 2018 and 2017, broken down by whether they involved either patients or other staff.
