Response to a request for official information



Thank you for your request for official information as received 22 November 2019 by Nelson Marlborough Health (NMH)¹, including subsequent clarification and amendment, where you seek the following information:

 All presentations to DHB EDs on Christmas Day, between 1201 and 2359, on December 25, in 2018, 2017 and 2016, broken down by emergency department/hospital (if there is more than one) and the ICD code/presenting complaint. Essentially every presentation by presenting complaint.

Can the request please be amended/updated to ask for all presentations from 0001 to 2359 on December 25?

Please see Table 1 below for Total Emergency Department (ED) Presentations 00:01 – 23:59 on 25 December [Christmas Day], by Hospital for Calendar Years 2016, 2017 and 2018.

Table 2 on the following page shows Total ED Presentations 00:01 – 23:59 on 25 December [Christmas Day], and International Classification of Diseases (ICD) code presenting complaint, by Hospital for Calendar Years 2016, 2017 and 2018.

The breakdown by Hospital and ICD code gives such low numbers that NMH declines to release exact numbers less than five due to risk of individual identifiability under Section 9(2)(a) 'to protect the privacy of natural persons, including that of deceased natural persons'.

Please note: Some presenting complaints for ED presentations on 25 December 2016 were recorded as Free Text Descriptions, and these uncoded presenting complaints are displayed as 'Other'.
