Response to a request for official information

Thank you for your request for official information, as transferred from the Ministry of Health and received 15 September 2020 by Nelson Marlborough Health (NMH)¹, followed by the necessary extension of time 13 October 2020, where you seek the following information:

Please note that all my questions relate only to endoscopy procedures:

1. In the last five years how many endoscopy consents were undertaken by nurses and could I please get a breakdown of the procedures these consents related to (e.g, gastroscopy, colonoscopy, ERCP, etc? I also want to know who conducted the procedure.

NMH response: The DHB does not undertake nurse led endoscopy consenting.

2. In the last five years how many endoscopy consents were done by doctors and could I please get a breakdown of the procedures these consents related to? I also want to know who conducted the procedure.

<u>NMH response</u>: In the last 5 years NMH performed 10,326 colonoscopies. As the DHB does not undertake nurse led colonoscopy, all colonoscopies would have been consented by doctors.

3. For the last five years, can you please state how many high-risk endoscopy procedures (based on what you classify as high-risk procedures) nurses consented patients to?

NMH response: The DHB does not undertake nurse led consenting.

4. In the last five years, how many deaths have been attributed to endoscopy procedures?

<u>NMH response</u>: The Patient Management System does not capture data for deaths attributed to endoscopy procedures, and it would take a significant amount of time and resources to go through individual patient files. As such, NMH refuses to respond to this part of your request under section 18(f) as 'the information requested cannot be made available without substantial collation and research'.

5. What is best practice in terms of who (i.e. doctors or nurses) should be consenting patients to endoscopy procedures? Should consent be obtained by the clinician conducting the procedure?

<u>NMH response</u>: At present consent is obtained by the endoscopist performing the procedure. We have been doing work around the process of nurse-lead consent, which works well in some other centres. We will be trialling nurse-lead consent with oversight from the NMH clinical lead and potentially rolling this out across the DHB if successful.
