Response to a request for official information

Dear

Thank you for your request for official information as a partial transfer of 3 (of 9) Points from the Ministry of Health and received 8 August 2019 by Nelson Marlborough Health (NMH)¹ where you seek information about implementation of recommended staffing requirements for school based health services;

The Ministry of Health recommends the following minimum ratios:

- one full-time equivalent (FTE) registered nurse (RN) to 750 students in decile 1–3 secondary schools
- one FTE RN to 200 students in high-needs contexts, such as alternative education units
- RN attendance for a minimum of one day per week during term time.

1. How many schools have taken up the recommendations?

Government policy has been to fund DHBs to provide school based health services to decile 1 to 3 schools and alternative education providers. This has recently expanded to decile 4 schools and will soon be expanded to decile 5 schools.

With this funding NMH contracts with the two Primary Health Organisations in Nelson Marlborough to provide health services to alternative education providers in the Nelson Marlborough district. There are no decile 1 – 3 secondary schools in the district.

NMH confirms that health service staffing requirements for alternative education providers meet the minimum recommended ratios (1 FTE RN to 200 students in high-needs contexts). Services are currently being rolled out to decile 4 schools and will roll out to decile 5 schools when funding becomes available.

2. Where are the schools that have taken up the recommendations?

The alternative education providers are based in Motueka, Nelson and Blenheim.

The alternative education providers are:

- OnTrac Waimea College
- Nelson Young Parent School
- Youth Nelson
- Abel Tasman Educational Trust (ATET)
- Marlborough Alternative Education
