2. Number of people admitted as mental health inpatients who identify as transgender or gender diverse in the last 12 months?

<u>NMH response</u>: A data search of our Patient Administration System, using clinical coding for the descriptions in Table Two below, captured less than five patients discharged from Wāhi Oranga Mental Health Inpatient Unit between 1 July 2019 and 30 June 2020 who identified as Transgender / Gender Diverse.
