# Response to a request for official information

Dear

Thank you for your request for official information received 15 January 2021 by Nelson Marlborough Health (NMH)<sup>1</sup>, followed by the necessary extension of time 15 February 2021, where you seek information about MDMA admissions.

Please provide a monthly breakdown of the number of people treated at Nelson-Marlborough
District Health Board from 2016 to 2021 to date (including through the COVID-19 period) for
MDMA related admissions. Can you please break it down by age groups of those treated and
ethnicity.

<u>NMH response</u>: Due to overall low numbers for the specified time frame 2016 - 2021, we find it necessary to withhold exact numbers, by month, for Questions 1 - 3 under section 9(2) of the Act to *'protect the privacy of natural persons, including that of deceased natural persons'*. In the circumstances, the withholding of that information is not outweighed by other considerations which render it desirable, in the public interest, to make that information available.

The volumes below have been identified by the International Statistical Classification of Diseases and Related Health Problems 10<sup>th</sup> Revision (ICD-10) code T43.62-*Poisoning by Methylenedioxy methamphetamine (Ecstasy, MDMA)*", as Primary diagnosis (reason for admission), or as a Secondary / Additional diagnosis if other drugs were involved.
