

NMH response:

Clinical units have minimal staffing levels, by merging areas we are able to bring the overall staffing in the combined area up to meet the needs of the patients in the combined area.

(c) Can you explain why our local hospital longer provides that level of essential [intensive] care?

NMH response:

Wairau Hospital has a High Dependency Unit (HDU), as has been the case since the hospital was rebuilt in 2009. The difference between an HDU and an Intensive Care Unit (ICU) refers to the staffing and is a result of the development of Intensive Care as a recognised Specialist programme with its own set of Standards defining levels of Intensive Care Medicine, as outlined at this link IC-1-Minimum-Standards-for-Intensive-Care-Units.pdf (cicm.org.au)
